

International Ship & Port Security

COMPANY SECURITY & SHIP SECURITY OFFICER (CSO/SSO)

In November 2001 the International Maritime Organisation (IMO) agreed to the development of new measures relating to the security of ships and of port facilities. The result was the International Ship and Port Facility Security (ISPS) Code. This code was enacted as an amendment to the International Convention for the Safety of Life at Sea, 1974 (SOLAS 74), as of 1 July 2004.

Drafted in 2003 as the Maritime Transport Security Act 2003 (MTSA), Australian legislation was amended to include Offshore Oil and Gas Facilities and renamed the Maritime Transport and Offshore Facility Security Act 2003 (MTOFS Act 2003). The amended Act and regulations govern Australia's Maritime Security Environment.

Within the Federal Government Department of Home Affairs, the Aviation and Maritime Security (AMS) Division (previously Office of Transport Security) has been established as the Federal body responsible for the regulation of the Act.

THE COURSE

Osprey International, in partnership with South Metropolitan TAFE WA, conduct Security Officer courses that comply with the above International and Australian Legislation.

The purpose of the course is to train participants as Company/Ship Security Officers (CSO/SSO) which will enable the participants to:

- Assess the security of a ship, and develop, implement and review a Ship Security Plan
- Implement security recording and auditing procedures

To be deemed competent, students must be able to demonstrate that they can:

- Assess security risk, threat and vulnerability
- Develop, maintain and supervise the implementation of a Ship Security Plan (SSP)
- Undertake periodic inspections of ships to ensure appropriate security measures are implemented and maintained
- Encourage security vigilance and awareness
- Ensure that security equipment and systems are properly operated, tested and calibrated (SSO only)
